

Automated Traffic Enforcement January 2023

During the month of **January**, Cedar Rapids Police Officers issued **9,062** citations identified by the Automated Traffic Enforcement system. These citations were issued to owners of vehicles traveling 12 MPH or more over the speed limit and/or running a red light. The Automated Traffic Enforcement Program has generated **\$558,502.00** during the month of **January**, and **\$5,365,226.32** for **FY2023**.

The City of Cedar Rapids partners with third party vendor, Sensys Gatso USA Inc., to assist with administering the ATE Program. For red light citations, Sensys Gatso receives **\$22.00** per paid citation and the City of Cedar Rapids receives **\$78.00** per paid citation. For speed citations, Sensys Gatso **\$18.00** per paid citation. The amount the City of Cedar Rapids receives for speed citations varies depending on the citation's value. Revenue generated from the Automated Traffic Enforcement Program is used for Public Safety purposes and has been utilized in the past to fund equipment needs for police and fire and social justice programs such as the Citizen Review Board and Urban Dreams.

Citations Issued by Residency of Vehicle Owner

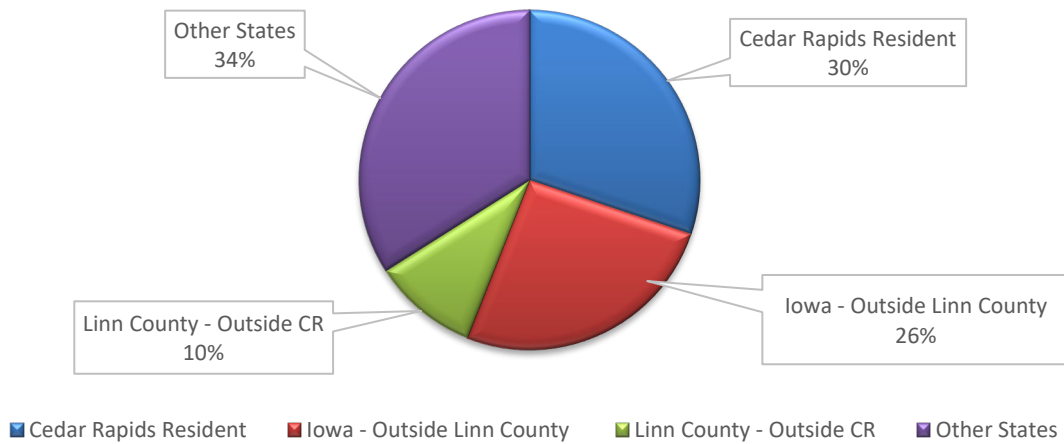


Figure 1. Percentage of citations issued by the residency of vehicle owner from 02-01-2022 to 1-31-2023

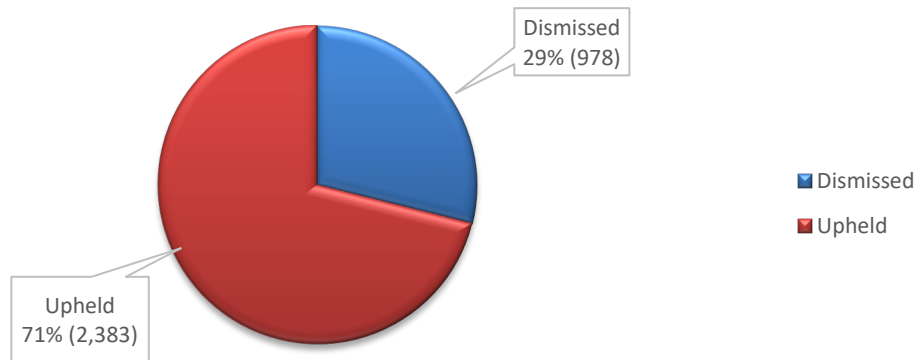


Figure 2. The City of Cedar Rapids provides the opportunity to vehicle owners who receive a citation from an Automated Traffic Enforcement Camera to contest the citation. This form is available online or a paper form may be requested from the Cedar Rapids Police Department. The Contest Citation form has a section for a vehicle owner to contest the citation, request a Municipal Infraction, or both. Figure 2 displays the percentage of contested citations that are upheld, dismissed, and in process from 02-01-2022 to 01-31-2023.

*In Process includes duplicate contest forms, incomplete contest forms, and contest forms pending review.

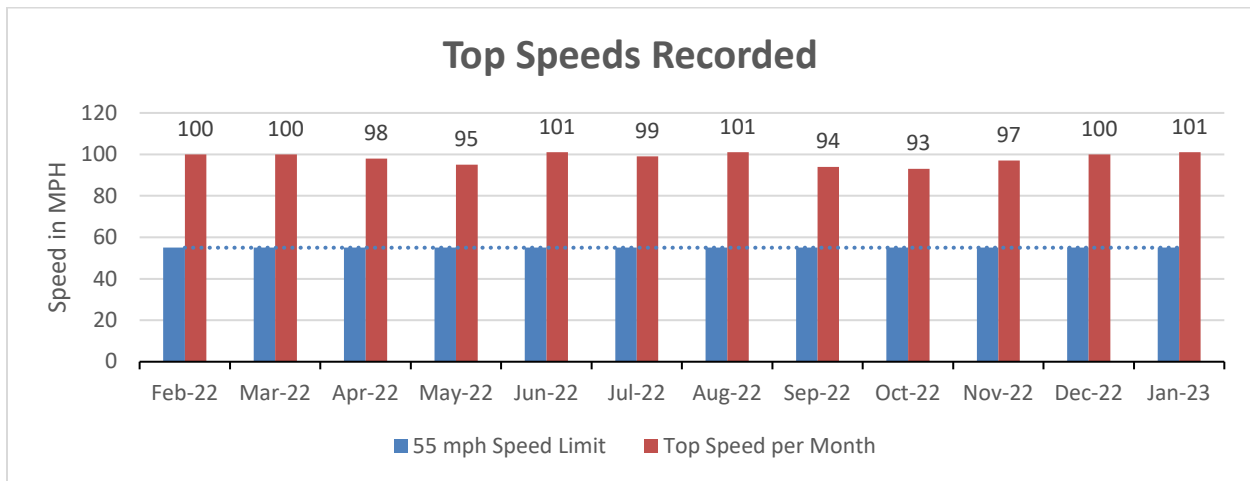


Figure 3. Top speeds of vehicles cited on Interstate I-380 separated by month from 02-01-2022 to 01-31-2023.

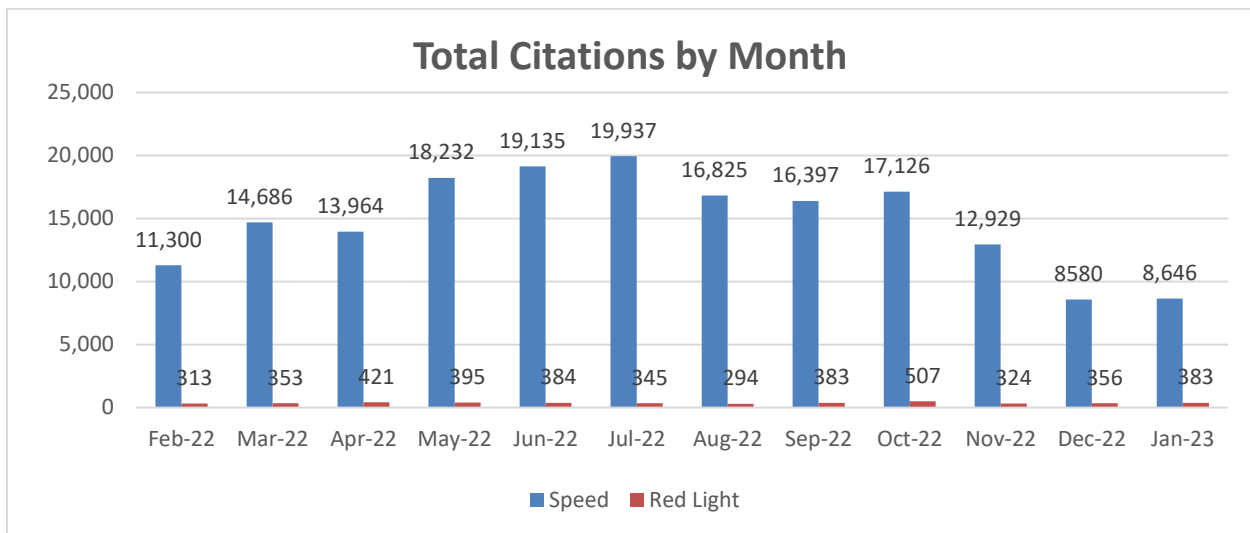


Figure 4. Red light and speeding citations were issued from 02-01-2022 to 01-31-2023.

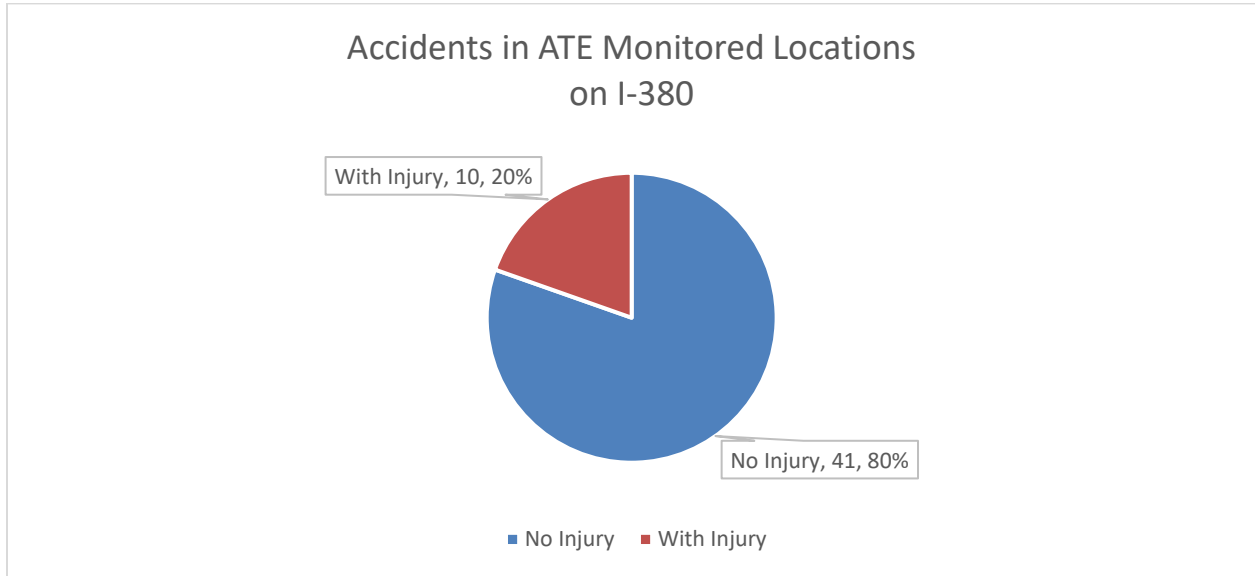


Figure 5. The pie graph shows accidents that occurred in ATE-monitored locations on Interstate I-380 with and without injury from 02-01-2022 to 01-31-2023. The trend of accidents going up in the winter months is expected from travel during inclement weather and poor road conditions.

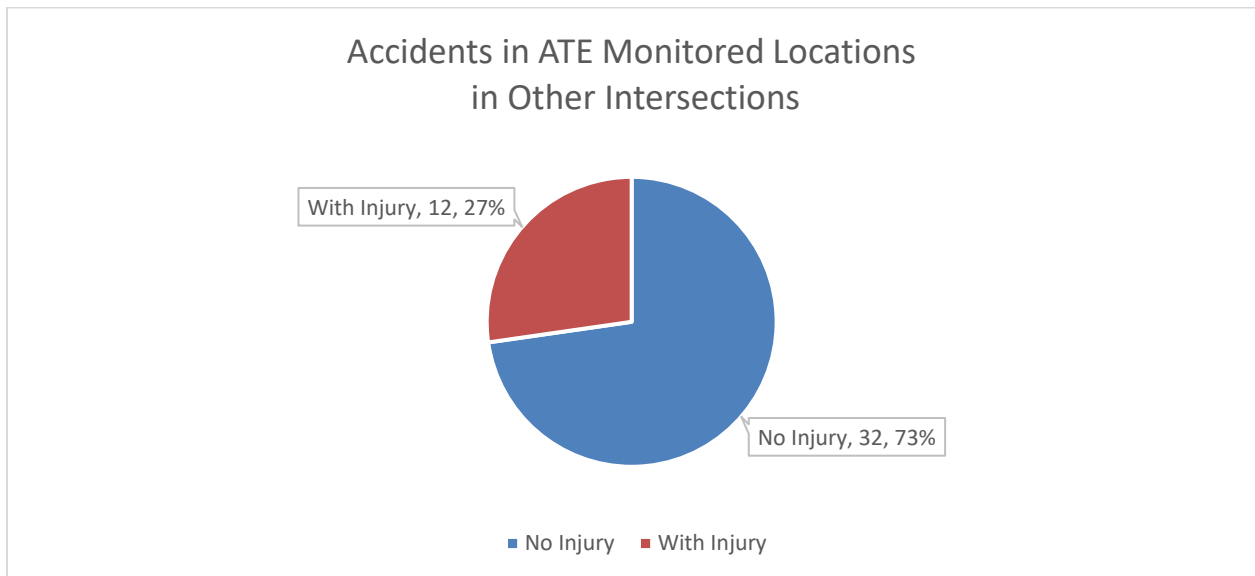


Figure 6. The pie graph shows accidents that occurred in AATE-monitored locations in other intersections with and without injury from 02-01-2022 to 01-31-2023.
